

FACTS	WHAT DOES APOLLO INSURANCE SERVICES, INC. DO WITH YOUR PERSONAL INFORMATION?

Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security number and Balance payment history • Insurance payment history and Claims loss history • Employment information and Checking account information
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Apollo Insurance Services chooses to share; and whether you can limit this sharing.

Who is providing this notice?	Apollo Insurance Services, Inc.

What we do	
How does Apollo Insurance Services protect my personal information?	To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.
How does Apollo Insurance Services collect my personal information?	We collect your personal information, for example, when you <ul style="list-style-type: none"> • apply for insurance or pay insurance premiums • file an insurance claim or pay us by check • show your driver's license
	We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.
Why can't I limit all sharing?	Federal law gives you the right to limit only <ul style="list-style-type: none"> • sharing for affiliates' everyday business purposes – information about your creditworthiness • affiliates from using your information to market to you • sharing for non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions	
Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. <ul style="list-style-type: none"> • <i>Our affiliates include:</i> <ul style="list-style-type: none"> • <i>Companies with Kinecta in the name</i> • <i>Financial companies such as: Kinecta Federal Credit Union, Kinecta Alternative Financial Solutions, Kinecta Financial Investment Solutions, Kinecta Financial Management Company</i> • <i>And others, such as Nix Financial and Nix Check Cashing</i>
Non-affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. <i>Apollo Insurance Services does not share with non-affiliated third parties so they can market to you.</i>
Joint marketing	A formal agreement between non-affiliated financial companies that together market financial products or services to you. <ul style="list-style-type: none"> • <i>Our joint marketing partners include insurance companies, insurance brokers and agents, and lending and financial institutions.</i>

Other important information	
Apollo Insurance Services, Inc. is required to send this notice to our customers on an annual basis. Once you opt out, you will remain opted out and do not need to do so again. If at any time you wish to change your opt out status, please contact us. State laws may give you additional rights to limit non-affiliate sharing. For residents of Alaska, California, Florida, Illinois, Maine, Maryland, North Dakota and Vermont, the information that you provide to us will not be shared with non-affiliated third parties, except as required or permitted by law, unless you contact Apollo Insurance Services and request your information be shared with non-affiliated third parties.
