

FACTS	WHAT DOES APOLLO INSURANCE SERVICES, INC. DO WITH YOUR PERSONAL INFORMATION?
Why?	Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	The types of personal information we collect and share depend on the product or service you have with us. This information can include: <ul style="list-style-type: none"> • Social Security Number • Insurance Payment and Claims Loss History • Employment and Checking Account Information
How?	All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information, the reasons Apollo Insurance Services chooses to share, and whether you can limit this sharing.

What we do

How does Apollo protect my personal information?	To protect your personal information from unauthorized access, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings. We also have strict policies, vendor requirements, and staff training all designed to protect your personal information and privacy.
How does Apollo collect my personal information?	We collect your personal information when you: <ul style="list-style-type: none"> • Apply for insurance or pay insurance premiums • File an insurance claim or pay us by check • Show your driver’s license In addition to collecting information from you, we also collect your personal information from others, such as credit bureaus.
Why can’t I limit all sharing?	Federal law gives you the right to limit only: <ul style="list-style-type: none"> • Sharing for affiliates’ everyday business purposes – information about your creditworthiness • Affiliates from using your information to market to you • Sharing to non-affiliates to market to you State laws and individual companies may give you additional rights to limit sharing. See below for more on your rights under state law.
What happens when I limit sharing for an account I hold jointly with someone else?	Your choices will apply to everyone on your account.

Definitions

Affiliates	Companies related by common ownership or control. They can be financial and non-financial companies. Our affiliates include: <ul style="list-style-type: none"> • Financial companies such as: Kinecta Federal Credit Union, Kinecta Financial & Insurance Services, LLC & Kinecta Financial Management Company, LLC.
Non-Affiliates	Companies not related by common ownership or control. They can be financial and non-financial companies. Apollo does not share with nonaffiliates so they can market to you.
Joint Marketing	A formal agreement between non-affiliated financial companies that together market financial products and services to you. Our joint marketing partners include insurance companies, insurance brokers and agents, lenders and other financial institutions.

Other important information

Apollo is required to send this notice to our customers on an annual basis. Once you opt out, you will remain opted out and do not need to do so again. If at any time you wish to change your opt out status, please contact us. State laws may give you additional rights regarding the privacy of your personal information.

For California Residents: We will provide a separate short form notice describing the rights of California residents to opt-out of the sharing of your non-public personal information in accordance with the California Financial Information Privacy Act. We have also provided a separate Consumer Privacy Notice notifying you of your rights under the California Online Privacy Protection Act and the California Consumer Privacy Act of 2018 on our website <https://apolloinsuranceservices.com/consumer-privacy-policy/>

For Vermont Residents: Under Vermont law, we will not share information we collect about Vermont residents with companies outside of our corporate family, unless the law allows. For example, we may share information with your consent, to service your accounts or under joint marketing agreements with other financial institutions with which we have joint marketing agreements. We will not share information about your creditworthiness within our corporate family except with your consent, but we may share information about our transactions or experiences with you within our corporate family without your consent.

For Nevada Residents: We are providing this notice pursuant to Nevada law. If you prefer not to receive marketing calls from us, you may be placed on our Internal Do Not Call List by calling **(800) 426-1088**. For more information, contact us at this toll-free number. For Alaska, Illinois, North Dakota, Maryland, Maine, New Jersey, Vermont and Florida Residents: The information that you provide us will not be shared with nonaffiliated companies for them to market to you or for joint marketing without your authorization.

For Insurance Customers in AZ, CA, CT, GA, IL, ME, MA, MN, MT, NV, NJ, NC, OH, OR, WI, and VA only. We do not disclose any nonpublic personal information about you as our customer or former customer, except as described in this notice. We may disclose the nonpublic personal information we collected about you, as described above to our affiliates, to companies that perform marketing services on our behalf or to other financial institutions which we have joint marketing agreements, and to other third parties, all as permitted by law and for our everyday business purposes, such as to process your transactions and maintain your accounts and insurance policies. We are permitted to disclose personal health information: (1) to process your transactions with us, for instance, to determine eligibility for coverage, to process claims or to prevent fraud; (2) with your written authorization; and (3) otherwise as permitted by law.

IMPORTANT PRIVACY CHOICES FOR CALIFORNIA RESIDENT CONSUMERS

You have the right to control whether we share some of your personal information. Please read the following information carefully before you make your choices below.

Your Rights

This notice is provided to you by Apollo Insurance Services, Inc. You have the following rights to restrict the sharing of your personal information with our affiliates (companies we own or control) and outside companies that we do business with. Nothing in this form prohibits the sharing of information necessary for us to follow the law, as permitted by law, or to give you the best service on your accounts with us. This includes sending you information about other products or services.

Your Choices

Restrict Information Sharing With Companies We Own or Control (Affiliates): Unless you say “No,” we may share personal and financial information about you with our affiliated companies.

NO, please do not share personal and financial information with your affiliated companies.

Restrict Information Sharing With Other Companies We Do Business With to Provide Financial Products And Services: Unless you say “No,” we may share personal and financial information about you with outside companies we contract with to provide financial products and services to you.

NO, please do not share personal and financial information with outside companies you contract with to provide financial products and services.
